






- 2-1 Stick outline figure [Unit:mm]






- 2-2 Quantity50 manufactured goods per one stick.

#### 3-4 Stick indication


Unit of stick will not be indicated.


Quantity: 20 sticks (1000pcs) per one box.


Put cardboard above and below the Thompson case for cushion.
